PROOF OF RESIDENCE IN THE CANARY ISLANDS/MELILLA:

- **Spanish citizens:** the registration certificate issued by the municipal council according to the model in Annex 1 of Royal Decree 1316/2001, accompanied by the national identification document (DNI) as proof of identity. Spanish citizens under 14 years old who do not have a DNI will only need to present the municipal registration certificate.

- **Foreign citizens:** (national residents of the 27 EU member states and Norway, Liechtenstein, Iceland and Switzerland): the registration certificate issued by the municipal council according to the model in Annex 1 of Royal Decree 1316/2001, accompanied by the national identification document (DNI) as proof of identity.

PROOF OF LARGE FAMILY:

In accordance with the Decree-Law 1621/2005, the official original valid large family certificate, or the document that proves this situation.

The shipping company will ask the interested parties for a copy of said documents, in order to enjoy the discount.

DOCUMENTS REQUIRED TO TRAVEL

When issuing the ticket: a photocopy of the valid registration certificate issued by the municipal council in force, as well as a document accrediting the identity of the person whose name features on the ticket (DNI or PASSPORT, original and in force)

When boarding: a document accrediting the identity of the person whose name features on the ticket (DNI or PASSPORT, original and in force)

Passengers with vehicles: it is necessary to present the TECHNICAL DATA SHEET.
